



Precision Events Ltd. - Terms and Conditions: Audio-Visual Hire and Services

1. Introduction

Welcome to Precision Events Ltd. ("we," "us," or "our"). These Terms and Conditions ("Terms") govern your use of our audio-visual equipment hire and event services ("Services"). By engaging our Services, you agree to be bound by these Terms. If you do not agree with any part of these Terms, you must not use our Services.

2. Definitions

- "Client" or "You" refers to any individual or entity hiring our audio-visual equipment or engaging our event services.
- "Services" refers to the provision of audio-visual equipment hire, installation, operation, and related event services provided by Precision Events Ltd.
- "Equipment" refers to all audio-visual equipment provided by Precision Events Ltd. for hire.
- "Event" refers to the specific occasion for which the Client hires our Services.

3. Service Provision

3.1. Equipment Hire: We agree to provide the Equipment as specified in the agreed-upon quotation or contract. The Client is responsible for ensuring the Equipment is used in a safe and responsible manner.

3.2. Installation and Operation: If included in the Services, we will provide professional installation and operation of the Equipment. The Client agrees to provide suitable access and conditions for installation.

3.3. Client Responsibilities: The Client is responsible for:

- Providing accurate event details.
- Ensuring venue suitability.
- Obtaining necessary permits and licenses.
- Providing adequate power supply.
- Supervising the event and attendees.

4. Payment and Billing

4.1. Quotations: Quotations are valid for 30 days from the date of issue.

4.2. Payment Terms: Payment terms are 30 days from date of invoice or prior to exhibition installation date – whichever comes first. A deposit may be required to secure the booking.

4.3. Online Card Fee: Paying via card incurs a £20.00 card service fee, applied to invoice upon confirmation of hire and payment method.

4.4. Late Payment: Late payments may incur interest charges.

4.5. Cancellation: In the unfortunate circumstance of having to cancel an event, the following charges apply:

2 weeks or more before the event - 25% charge

1 week before the event date - 50% charge

48hrs before the event date - 100% charge

5. Equipment and Liability

5.1. Equipment Condition: The Client acknowledges that the Equipment is provided in good working order. Any damage or malfunction must be reported immediately.

5.2. Client Liability: The Client is responsible for any damage to or loss of the Equipment during the hire period, excluding normal wear and tear.

5.3. Limitation of Liability: Precision Events Ltd. shall not be liable for any indirect, incidental, special, or consequential damages arising from the use of our Services.

5.4. Insurance: The client is advised to have their own public liability insurance.

6. Intellectual Property

Any software, designs, or other intellectual property provided by Precision Events Ltd. remains our property.

7. Governing Law

These Terms shall be governed by and construed in accordance with the laws of England and Wales.

8. Dispute Resolution

Any disputes shall be resolved and raised within 14 days of invoice date. Disputes are sent via Project Manager to accounts@precisionevents.co.uk.
